5. PRESIDENT'S REPORT

We had many successful rides this year. Thank you to our Ride Organisers. Without them we have no sport, so they are precious. Then there are the markers to go up. Ask our Legend, Julie Woods and she will tell you how the riders would go out and mark the course when they arrived at the base. How would that go down now? Then all those markers have to be taken down. Remember that as you drive out the gate.

Then there are other people we rely on, our Volunteers. The Check Points, our water boys like Paul, the pencillers and others in the Vet ring, around the camp and the track. 8. ITEMS FOR DISCUSSION

8.1 Rides Running under VERA Incorporation

Motion: That all rides run be run under VERA Inc.so removing the financial burden from Ride Organisers (unless they specifically want to run the ride for charity e.g. Moyston)

Motion Lost

Although this motion was lost, the membership felt that there was some merit in discussing ways in assistance can be provided to better support ride organisers. The members wished the SMC to put together a package to help ride organisers. This will be discussed further at the SMC meetings

8.2 Electronic Timing System

Motion: That VERA Inc. purchase the Electric Timing System from AERA prior to the VERA State Championships 2019 at a total cost of \$10,978.00 (Including GST)

Motion Disallowed due to existence of previous motions that need to be rescinded

After much discussion the majority of members present agreed that the concept of the system is good but there are still questions that need answers, such as:

- Who will be responsible for the equipment?
- Where will it be stored when not in use?
- Who transports the equipment to rides?
- What back up support is in place?



- Will ROs be liable for breakages not necessarily their fault, i.e. equipment arrives and is already damaged?

At this point in time the cost outweighs the number of Ride Organisers who would be prepared to use it. A suggestion was provided that the equipment be hired for this year's State Championship ride as that ride is the only 160k ride on the Victorian Calendar so far this year.

A straw poll was taken with a very slight majority of members indicating they were not in favour of purchasing the Electronic System.

The SMC will look into the purchase further and provide feedback to members when the above questions have been addressed.

8.3 Membership Categories

Item for discussion proposed by Paul Nugent and seconded by Rebecca Williamson. That either Associated Members be provided with voting rights or a new membership category be created for non-riding members to have voting rights

There is no provision in the current VERA Constitution to allow Associate Members to vote. This would need to be put to the next AGM as a motion to change the constitution. Upon discussion this issue resolved into how we can better support our volunteers who currently pay full membership.

The SMC will look at ways of providing some financial benefits to volunteers to reduce the cost of membership.

8.4 AERA Constitution

A brief explanation was provided of the changes contained in the draft AERA Constitution. The change in the management structure and the imposition of a cap on the smaller states was raised as a sticking point for members. It was felt that all states should have the same level of representation at the Management Committee table.

9. Other General Business

Items of general business from the floor were called.

Vanessa Smith put forward a proposal that 1st, 2nd and 3rd placings for intermediate rides should be acknowledged. These riders would still retain their completion award, but novice ride speeds and heart rates would still be applied to ensure horse welfare remained foremost.

The rationale for this suggestion is that many people these days do not have enough time to train horses for 80km competitive events. Prizes could be a simple ribbon and would not be at the same level as those for the competitive events. Best Conditioned events would not be appropriate given there are no weight divisions in intermediate rides.



This is currently being done in America and Vanessa believed it encourages competitive sportsmanship and a desire to achieve more at a 40km level. It was also thought that it may encourage riders to increase their competition distance over time with more experience and confidence gained at a 40km level.

The Committee will look further into this suggestion as the current rules do not support competitive intermediate rides.
