6. VERA TRAINING WEEKEND

VERA had also approached AERA to have another party intervene in the hope that a request from AERA would gain adherence to the rules.

The process for initiating the Disciplinary Panel was discussed. The process of determining whether any conflicts of interest (either positive or negative) exist within the Disciplinary Panel lies with the Committee. Once this process had been finalised the remaining Disciplinary Panel members will be contacted to see if anyone wished to declare themselves ineligible. If there are insufficient people available to form a Disciplinary Panel the Committee will then constitute itself as the disciplinary subcommittee.
