# 10.2 Calendar Coordinator/Insurance

## **Ride Applications**

A ride application has been received from the Ararat Pony Club to run their annual event on 7 & 8 August 2021. Ride distances will be 5, 10 and 20km on Saturday with 20, 40 and 80km rides being run on Sunday. They have requested to be allowed to rollover their Ride Application Fee from the 2020 event which was approved.

**Motion 06/02/2021**: That VERA accept the ride application from Ararat Pony Club to run their ride on the 7 & 8 August 2021 consisting of a ride distances of 5, 10 and 20km on Saturday and 20, 40 and 80km on Sunday.

Paul advised that the Snake Valley ride will not proceed this year. Lancefield are still trying to get something happening but not a firm possibility at this stage. Ken Bradley has found a recreation reserve at Mia Mia and is trying to put together a ride.

Hans has spoken to Ken Bradley and Martin Mizzi about putting rides on. Spoke a bit about the support network for rides. The venue is there but he must have a dedicated group of people on whom he can rely.

The Dergholm ride was discussed, and the difficulty being experienced getting a second vet. We may need to obtain a vet from SA. Ledgwin may be able to help out. Lot of vets are keens to do rides.

## Ride Application Fee

The SMC resolved to defer the discussion on the increase in ride application fees until the December meeting. Mez will include this item on the agenda for that meeting.

## **Transfer of Ride Deposit**

Kerrie raised the question about refunding the ROs who paid their ride application fee in 2020 and are now not going to run a ride for this year. AERA does not charge any fees until the ride is run. It was agreed that Snake Valley, which is currently the only ride not proceeding in 2021, should have their ride application fee refunded.

It was agreed that she would take any orders for items out of stock and advise that we have a minimum order level that needs to be reached before goods can be delivered.

#### 10.7 Point Score Officer

The appropriate access to AERASpace has been provided to Bek as the Pointscore Registrar. Bek is to contact Caroline to organise the training. Kerrie will organise to pick up the laptop from Caroline and take it to the Dergholm ride to pass onto Bek.

#### 10.8 TPR Coordinator

It was agreed that the SMC recognise those people who have achieved their 3 rides by letter and by social media post. We need to remind others who have attended TPR schools to send in their provisional card, once the 3 rides have been done, to Ellen.

TPRs had been found for Dergholm and Toongabbie.

## 11. GENERAL BUSINESS

### 11.1 Ride Application Form

The Ride Application form will be updated to require only the following information to be gathered:

- Ride Name
- Ride Base Location Address
- Ride Organiser Name, Ride Organiser Email, Mobile

- Ride Contact Person (if different to the Ride Organiser), Email and Mobile
- Dates: 1<sup>st</sup> preference
- Distances Saturday Ride Distances, Sunday Ride Distances
- Incorporated Body and Inc/ABN No.
- Dual affiliation Indicate that it is the RO that applies for this and we only need to know that they have applied, advising of the km limit for affiliation
- Notification of the Key Ride Roles needs to be with the VERA SMC at least 2 months prior to the event. Triggered by a contact from the Secretary 3 months prior to the event. Add the First Aid Officer to the list of people.
- Add Paul's mobile and email address
- No event advertising or electronic media promotion can be initiated prior to SMC approval of the ride application
- Name of Incorporated Club
- Postal address, contact details.
- Do not need a website address
- Remove: Club incorporated down to the Number of people including spectators at biggest event fields.
- Include: Does the Club have:
  - o Risk Management Plan
  - Bio-security Measure
  - o COVID-Safe plan
- Does the club provide any Remove
- After enquiry Remove
- Leave signature in
- Leave the rest as is

Linda to draft up the form and send around to everyone for comment.

## 11.2 2021 State Championships

It was agreed that it was not necessary to go through the EOI process as the event was simply rolled over from last year due to COVID restriction. The requirement for a call for EOIs for the 2022 State Championship was also discussed. As this event will be the responsibility of the Committee running the Quilty event there is no need to call for EOIs for 2022.

#### 11.4 COVID-19 Guidelines for ROs
